## CITY OF BURNET CHARTER AMENDMENT COMMITTEE MINUTES

On this the 14<sup>th</sup> day of September, 2023, the 2023/2024 Charter Review Committee of the City of Burnet convened at 1:00 p.m., at the City of Burnet, Council Chambers, 2402 S. Water (Hwy. 281 South), Texas with the following members present, to-wit:

Call to Order: Mayor Gary Wideman called the meeting to order at 1:00 p.m.

<u>Roll call:</u> In attendance: Gary Wideman, Philip Thurman, David Vaughn, Charlie Zech, Kelly Dix, Habib Erkan, Jr., Paul Farmer, Stan Hemphill, Ken Graham, Calib Williams

<u>Introduction of Process:</u> City Manager, David Vaughn provided a brief history of the last review and the timeline provided for the 2023/2024 committee review. Mr. Vaughn also provided a report on the 2022 staff level review of all processes that were conducted to eradicate any discrepancies in the codified version. The staff review went back to the original Charter and proceeded through to the last revisions in 2018.
