DISCUSS AND REVIEW:

- Boys and Girls club – Installation of a sports court has brought juveniles who do not attend the club to the area and are using the facilities creating unique issues for the staff both during and outside of business hours.
- Delaware Springs – Traffic light on US 281 continues to be a complaint of vehicles running the red light.
- Shady Grove – Light on the pond is blinding to drivers at night as they exit the subdivision, speeding, and juveniles congregating on Andy's point.

Discuss and review: Meeting topic recommendations: Future meeting ideas included discussion about the eclipse and SRO discussion with all of the SRO's and what they are seeing in the schools.
