<u>CALL TO ORDER</u>: The meeting was called to order by Board Member David Vaughn at 3:00 p.m. and quorum was established.

CONSENT AGENDA:

Approval of the February 15, 2021 BEDC Regular Meeting minutes

Board Member Crista Goble Bromley moved to approve the consent agenda as presented. Board Member Brad Zehner seconded. The motion carried unanimously.

ACTION ITEMS:

Discuss and consider action: Draw Request for Fromberg Construction, LLC for the Highway 281 South Commercial Park: Board Member Crista Goble Bromley moved to approve the pay application for payment for Fromberg Construction, LLC., in the amount of \$120,916.77 upon completion of the punch list as stated by the City Engineer, Cuatro Consultants, LTD. Board Member Danny Lester seconded. The motion carried unanimously.

Discuss and consider action: A RESOLUTION OF BOARD OF DIRECTORS OF THE BURNET ECONOMIC DEVELOPMENT CORPORATION APPROVING A DECLARATION OF COVENANTS CONDITIONS AND RESTRICTIONS TO BE PLACED ON THE REPLAT OF LOT NO. 7-C EASTSIDE COMMERCIAL PARK: Board Member Habib Erkan presented the draft of the covenants for review. Changes will be made and returned to Board for action. No action taken.

Discuss and consider action: A RESOLUTION OF BOARD OF DIRECTORS OF THE BURNET ECONOMIC DEVELOPMENT CORPORATION APPROVING A DECLARATION OF COVENANTS CONDITIONS AND RESTRICTIONS TO BE PLACED ON 13.51 ACRES OF LAND TO BE SUBDIVIDED AS THE CROSSING AT 281: Board Member Habib Erkan presented the draft of the covenants for review. Formal offer submission will not happen until after the Contract Covenants have been finalized and approved by the board. No action taken.

<u>Discuss and consider action:</u> Related to the potential sale of all or portions of the Crossings at 281 South <u>Commercial Park:</u> Board Member David Vaughn informed all present that David Drake had contacted him and was working on some possible commercial interest in the Crossings at 281 South. All progress will be reported at a future meeting. No action taken.

<u>Discuss and consider action: 2022 Summer Series:</u> Board Members David Vaughn and Danny Lester provided an update on the cost of headliners for the 2022 Summer Series. Options were discussed to research the possibility of more of a festival type atmosphere event with music or possibly providing a free event to the community. Board Member Lester and Vaughn will report research findings at a future meeting. No action taken.

<u>Discuss and consider action: Commercial Drivers License (CDL) Program:</u> Board Member David Vaughn updated all present on the changes required to obtain a Commercial Drivers License and the expense caused by the new legislation. The City Human Resources Department is currently looking at options to address the situation in a cost effective manner. Board Member Vaughn will update the Board as the information becomes available. No action taken.
