<u>CALL TO ORDER</u>: The meeting was called to order by Board President Cary Johnson at 3:00 p.m. and quorum was established.

Approval of the March 19, 2024, BEDC Regular Meeting minutes: Board Member Philip Thurman moved to approve the consent agenda as presented. Council Member Katy Randall seconded. The motion carried unanimously.

ACTION ITEMS:

<u>Discuss and consider action: Related to the potential sale of all or portions of the Crossings at 281 South Commercial Park:</u> Board Member David Vaughn updated all present that the hotel plans to begin on or around May 2024. No action was taken.

<u>Discuss and consider action: Related to the sale of all or portions of the Eastside Commercial Park located on Highway 29 East:</u> Board Member David Vaughn informed all present that construction crews have begun to mobilize for the Tractor Supply project. No action taken.
